This document contains the **Agenda Topic Summaries** of the background information for all of the items to be considered by the thirteen Conference committees of the 73rd General Service Conference (GSC). The topics will be discussed by their respective committees, and the committees **may** or **may not** send recommendations to the whole Conference for consideration and vote.

The **purpose** of these summaries is so that they may be used as a tool by General Service Representatives (GSRs) to provide their group with pertinent information to facilitate an informed group conscience and then to convey that group conscience to the Area 46 Delegate. In many cases, the summaries serve as an appetizer and those GSRs and groups with an interest in more information can obtain the complete background our Area 46 service site. Not all topics make for fruitful discussion at group level, and this is intended to help you narrow that down. Many of the agenda topics are only for that specific committee (such as reviewing a draft or progress report on the development of a piece of literature) and do not require a group conscience, but they still may be of great interest to read and share. Other topics appear every year, such as reviewing workbooks and kits used by Public Information, Corrections, etc. Local committees may wish to share their experience. These summaries may also be used by other members of our Fellowship to communicate valuable information about the agenda topics and, where appropriate, to convey opinions to the Delegate. The questions in this section, if any, are intended to be a guide, not a limit, for your sharing sessions. Feel free to interpret them broadly.

| Historical Context; Why is it on the Agenda? | In 2017, the Conference C.P.C. committee began discussing the potential development of a LinkedIn page for Cooperation with the Professional Community committees and requested that the trustees draft a report exploring all aspects of this social media tool, whether it was feasible within the Traditions, and develop a potential implementation plan. A report from the Trustees was presented in 2018, at which point the Conference C.P.C. committee recommended the development of an A.A.W.S. page on LinkedIn that could help professionals find information about A.A., broaden the reach of the <i>About A.A.</i> newsletter for professionals, and potentially deepen the pool of Class A Trustee candidates. The 2019 C.P.C. committee reinforced the 2018 request, asking for a disclaimer that "promoted" content on the LinkedIn page was not affiliated with A.A., adding links and content referencing how A.A. cooperated with professionals, and requesting an annual report tracking how the LinkedIn page was used. | | The focus group met and discussed barriers to referring or providing information to clients about A.A. The entire focus group report is in the background. Barriers included confusion about spirituality vs. religion, that professionals don't know how to "refer" people to A.A. since A.A. has no intake process, confusion about anonymity, confusion about A.A.'s policy on medication (there is none), understanding who is an alcoholic, knowing the types of meetings that exist, confusion about A.A.'s singleness of purpose, and sometimes non-existent relationships with local A.A. resources. The focus group hoped that A.A. could clearly communicate that recovery is an evidence-based service, that it is accessible, and that it is inclusive. |

| Historical Context; Why is it on the Agenda? | The International Corrections Meeting in Alcoholics Anonymous made a proposal (which is in the background) that content regarding sponsorship of persons in custody by outside members of the Fellowship be added to existing A.A. literature. The proposal notes that there is a lack of information in AA literature regarding sponsorship of persons in custody by A.A. members not in custody (on the "outside"). They note that persons in custody and corrections professionals have requested outside sponsors. | | | | |
| | There are many factors that impact sponsorship of members in custody, and different communities have responded to those factors in different ways. Some committees have developed sponsorship programs that allow persons in custody to place their outside sponsor on their visitor list. Other persons in custody are sponsored through the Corrections Correspondence Service, but facility staff read all incoming and outgoing mail. Others are sponsored through the phone or via video, while in one facility, meeting volunteers have a good relationship with facility staff and can have private meetings within the facility. In some Canadian facilities, outside members can take persons in custody out of the facility through "Temporary Escorted Absences." | | | | |
| | In response to this proposal, a request for sharing was sent out to the fellowship. Fifty-four responses from the membership across corrections service positions and areas were received. A six-page report details the responses, which included inside visitation sponsorship, sponsorship by mail, sponsorship by video, and sponsorship between members, as well as additional ways to provide sponsorship to persons in custody. This is described as an "enthusiastic response" in the background, so the trustee's Corrections Committee asked for a draft service piece, which is also in the background, that could be added to the Corrections Workbook. | | | | |
| | The proposal suggested content on sponsorship could be included in a number of other pamphlets, books, service materials, and Grapevine publications. The full list is in the background. This would be in addition to the service material that has already been developed as a result of this proposal. | | | | |

| Agenda Topic | Discuss service piece, "Safety and A.A.: Our Common Welfare" (SMF-209) and its revisions. |

| Historical Context; Why is it on the Agenda? | "Safety in A.A.: Our Common Welfare" is a service piece first developed in 2017 that arose from several safety-related discussions that were happening at all levels of A.A. Many of these original discussions included conversation about literature updates, guidelines, or policy statements related to safety. The General Service Office had also been receiving reports from members regarding unsafe conditions and behaviors within A.A., and media also published stories about safety issues in A.A. and were inquiring to GSO about the Fellowship's safety policies. Staff at the office had no written material to share in relation to internal or public queries related to safety. This service piece was originally written by a GSO Staff ad hoc committee and approved by the AAWS board in February 2017. |
| | A Yellow Safety Card was approved in July 2017, which was criticized by some members of A.A., prompting the Board to review, possibly revise, or discontinue the card. But there were no changes to the Safety Card or to "Safety in A.A.: Our Common Welfare." |
| | After the publication of "Safety and A.A.: Our Common Welfare" and the Yellow Safety Card, the topic of safety remained a common workshop theme throughout the fellowship. This helped broaden and inform discussions, so an update of "Safety in A.A.: Our Common Welfare" was made to incorporate this latest information. Additionally, a Safety Flyer was also explored. While the revision was initially prompted by concerns about the safety card, it was informed by sharing at multiple events (such as Regional Forums), where the conversation focused on predatory/illegal actions, misconceptions about anonymity, dealing with health emergencies, racism in A.A., and the impact of sharing gender identity/pronouns. All this sharing prompted revisions to the safety pieces in April 2021. |
| | After these revisions, between 40 to 60 groups and individuals provided feedback; some feedback was accepting of new material, while others were concerned it could be perceived to be inconsistent with our Traditions and our scope. Another revision was undertaken, this time reviewed by legal counsel and distributed in March 2022. This revision resulted in more feedback, much of it upset about the removal of specific language addressing diversity and inclusion, prompting this agenda topic. |
| | The background includes four proposed agenda items from members and groups that another revision to "Safety and A.A.: Our Common Welfare" be made to revisit changes made between 2021 and 2022. These proposed agenda items focused on the removal of language regarding |

| | diversity and inclusion – which stated that "racism in A.A. is a safety issue" and stated an acknowledgement that "we all operate within some unearned privilege." Also removed were passages about gender pronouns and "special interest" groups, like groups for women, the LGBTQ+ community, young people, Black and indigenous people of color (BIPOC), and certain professions like lawyers and doctors. |

Historically, some material (like the preamble and the Responsibility Declaration) were initially service material that have become part of the Conference's purview, and some service material has been added to Conference-approved literature. |

| Historical Context; Why is it on the Agenda? | The groups and districts in Texas and an individual in Arizona proposing this change believe adding language could correct the current inconsistent language throughout our literature and clarifies that the General Service Board is the recipient of our contributions, not the General Service Office. The office processes contributions. Currently, they believe this is not clear in our literature. |
| | Per the proposal, some items of literature correctly state that our AA voluntary contributions are received by the General Service Board, while other items of literature may require more clarification. By reviewing this proposal, the presenters of these items hope to provide consistent information throughout our literature that clearly represents and explains our service structure and the roles that each service entity fulfills. |

The account has 658 followers, an increase of 6.82 percent in the past 90 days. Nearly 38 percent of followers are under age 45, and while the majority of followers are female, about 33 percent of followers are male. |

The background material contains excerpts from each of the progress reports from the quarterly meetings of the Tools to Access the Big Book (TABB) subcommittee of the trustees' Literature Committee, as well as more thorough reports in Documents 1 through 5. TABB reviewed all the feedback from the Fellowship on the video that was made available last year by a previous subcommittee (RIPTAB). The TABB subcommittee has been reviewing final drafts of whatever completed material is available on a quarterly basis, with each member providing feedback with the expectation that additional rounds of refinements ensure the tone and tenor of each chapter are faithful to the guidance and suggestions contained in the Big Book. |
| | In January 2022, the TABB subcommittee reviewed several proposed agenda items sent in to stop the development of a plain language Big Book. Of note in these proposals were concerns regarding political intentions, the eradication of God, and the removal of all gendered language. The TABB subcommittee affirmed in the report that the objective is to achieve a translation into plain language that meets the accessibility needs of those with a 5th-grade reading level. The request to prospective translators noted specifically that "we are seeking simplification of vocabulary, syntax, and style to bring it into alignment with current plain language guidelines" and that "sensitivity to A.Aspecific language will be key." The committee further discussed potential gender changes at the February 2022 meeting, emphasizing that there is no intent or desire to remove gender from the text. It was also made clear that under Article 3 of the Conference Charter and the Bylaws of the General Service Board, the Steps themselves will not be modified, altered, or extended. While the translator is a professional, this will be a collaborative effort. A.A. members through the TABB subcommittee, G.S.O., the trustees' Literature Committee, and ultimately the General Service Conference will guide the process. The January 2022 progress report also contains a roadmap to guide workflows and address the unique circumstances of this sort of translation, including touchpoints with the General Service Conference. Also because of the high level of interest in the process of translation, the background information contains examples of plain language translation. |
| | At their January 2023 meeting, the TABB Subcommittee reported that a formal agreement between Alcoholics Anonymous World Service (AAWS) and the writer was finalized in May 2022. The writer has submitted chapters to Publishing, as well as the preface, the foreword, and the beginnings of a glossary. The Publishing Department has committed to providing the subcommittee with written updates monthly. The subcommittee agreed to forward to the 2023 Conference Committee on Literature a progress report regarding the translation. |
| | Given the fellowship's deep and wide interest in this project, the subcommittee has greatly considered balancing well-defined delegated authority with unity and transparency. 

way to reach the newcomer. The committee requested that a progress report or draft pamphlet be brought to the 2023 Conference Committee on Treatment and Accessibilities.

Since the 2022 Meeting of the General Service Conference, the Trustee's CPC/TA committee created a Working Group charged with updating the pamphlet, keeping in mind the suggestions made at the April 2022 General Service Conference. Over a series of meetings, the Working Group has narrowed the story selection to eight. The Working Group has also been working on updating the introductory text of the pamphlet.

The Working Group also hoped to revise the back pages of the pamphlet to ensure that readers of "A.A. for the Older Alcoholic" would easily find other helpful resources, in particular, other conference-approved literature available in large print. A suggestion was made to add a QR code to the pamphlet, which could direct users to large-print material. It was also observed that using a QR Code to point readers to electronic resources would allow readers to enlarge PDFs with their own electronic devices, thus making most Conference-approved literature available to those with vision impairments. Although the Publishing Department indicated that they are still evaluating the use of QR codes at this time, the Working Group suggests that once this QR Code piloting evaluation is complete, staff consider adding a QR code to the pamphlet "A.A. for the Older Alcoholic."

| Historical Context; Why is it on the Agenda? | For the last four International Conventions, at the choice of the respective chair, one of the Big Meetings is closed with the Lord's Prayer, one is closed with the Serenity Prayer, and one is closed with the Responsibility Statement. At the 2021 General Service Conference, the Conference Committee on International Conventions/ Regional Forums (IC/RF) discussed methods of closing the Big Meetings at the next International Convention in 2025, particularly the use of the Lord's Prayer. A survey was conducted in 2022 to gather feedback from the Fellowship regarding methods of closing the Big meetings, including the use of the Lord's Prayer and potential alternatives (e.g. Third Step Prayer, Seventh Step Prayer, A.A.'s Declaration of Unity). In December 2022, the Trustees IC/RF Committee reviewed and discussed the survey results and concluded that the data "did not reflect an overwhelming desire by the respondents to change the current practice". Calculating the English, French, and Spanish responses in total, the Trustees committee noted that over 50% responded favorably to keeping with the current practice. The |
| | background material includes the survey data, which does show that almost 40% of English respondents and 55% of Spanish respondents wanted to end the practice, and that 47% of English respondents and 74% of Spanish respondents wanted to substitute another option for the Lord's Prayer. |
