Hello Area 46!

The August assembly was amazing. I love watching the A.A. Service structure in action! A huge thank you to District 3 for providing an excellent venue and excellent hospitality. As always, our technology committee worked very hard and produced a quality hybrid event.

We got to see the minority opinion swing a vote to the other direction, we got to hear from one of our wonderful class B trustees Deborah K. Her personal recovery story was inspirational and her journey moving down the triangle in general service clearly had her high power's hands all over it.

Eloy, our Delegate, challenged us to take back a discussion to our groups regarding how Area 46 should handle residency requirements for those who wish to serve at the area level. The discussion is about geographical boundaries of where the potential trusted servant resides. Currently, our AIP does not specify that area servants must reside within the boundaries of Area 46. On Sunday I reminded the assembly that many areas in the general service structure are talking about how to handle virtual groups – how to assign them a district, how can they serve, etc.

Consider this question in your groups and districts:

Should Area 46 Trusted Servants (Delegate, Alt Delegate, Area Officers and Area Committee Chairs) be required to live within the geographical boundaries of Area 46? I encourage you to talk this out in your groups and districts so we can have a truly informed group conscience at the December assembly.

Delegate Reports and Workshops

I have really enjoyed traveling to the districts when Eloy gives his delegate report. I've had the privilege of doing a workshop for several districts and have a few others coming up. Part of what makes Area 46 so great is that each district is unique. Each district has its strengths and also has its challenges. Workshops are a great way to address some of the challenges that a district is facing. As servants in AA, we are all in this together. I am happy to schedule a date to do a workshop on the same day as Eloy's delegate report or at another date.

Thank you to all who participated at our first August Area 46 assembly in Socorro. It was great to see friends, old and new, and roll up our sleeves to carry the message once again. We also had the pleasure to meet one of our trustees from AA World Services, Debra K., who shared with us her experience and a slice of what goes on at the board level of Alcoholics Anonymous.

During Debra's sharing session on Saturday night, she responded to the question "Will AAWS ever become truly self-supporting?" This question arises out of the fact that a significant amount of funding (well over half) for AAWS comes from literature sales outside of Alcoholics Anonymous. Debra's answer was that AAWS will not become fully self-supporting until many more of our groups fully understand our financial responsibility. To me, that means fully understanding the intent of my 7th tradition contribution at my home group meeting or any AA meeting I attend. When I put a contribution in the basket, I know that if first goes to support the group and keeps the meeting going- i.e., rent and coffee. But after those expenses are covered, my contribution then goes on to support the entirety of our

service structure and AA as a whole. Therefore, in the big picture, it is my contribution that allows the group to be self-supporting, and then it's my group's contribution that allows the rest of AA be self-supporting. The more I can give to the group, the more the group can support.

Whether or not AAWS can be self-supporting has to start with me and every one of us who drops money in the basket. Is "a dollar" enough? Questionable. Two dollars? Maybe. The price of a cup of coffee today? Getting closer. Alcoholics Anonymous belongs to us and we are the ones that have to take care of it. Virtual Assembly Planning Meetings

Can we reduce our area budget by eliminating Travel to Planning Meeting costs

Pros and cons of virtual planning meeting (discussion)

Looking at budget wise it would allow for \$1500 allocated back into the budget. What is actually budgeted for each person is not enough to cover gas and time. Plus, the tech side of setting up for the meeting. Equitable way of each spending the amount of time getting ready.

Maybe not the orientation planning meeting.

Personal interaction and learning tips and tricks to how to be of service at the area level.

Language of the heart is hard to do online. Understand it's hard to travel long distances but the point is we're being of service to the area. Area isn't gonna be able to cover all costs, but we are self supporting through our own contributions.

Does cost money and when trying to present a balanced budget. But can we put a price on getting together. The upside maybe that's an opportunity for lots of service

Planning meeting is for the next assembly Why isn't it in the city where the assembly is being held.

This conversation is coming up because of finances. Trusted servants decided years ago to go to ABQ because it's the center of the state. There's been a time that trusted servants weren't assisted financially then that changed. Alcoholics paid their paycheck to get drunk but can't pay to be of service to alcoholics.

Willing to go to any length for sobriety. The budget for travel is just to cover a piece of the cost not all of it.

SUMMARY:

We value our in-person time together. If we take the cost out, look at the value of the workshop, look at the value of time setting up for hybrid. We are divided on what direction to go on this; maybe we should look at this a little more. This was a discussion only topic no decisions to be made

12th Step Fund

Currently a lump sum available to committees \$1000 available to all the committee chairs for traveling to workshops or carrying the message. Used to be divided up but some committees used all theirs where others didn't use it at all. It seems now that it's not being used.

Would there be better utilization of funds if divided among committees (discussion)

One-time requested funds were told no so she doesn't want to have to go through those hoops again. Maybe if it was easier to access.

After the past 2 years we haven't been able to travel or do large gatherings.

Past 9 years it hasn't been used

Nobody really knows what it can be used for. Just ask the chair and it can be figured out if it's 12 step work

Sometimes it feels like our group funds are about having assemblies and getting us there; is 12 step work actually being done. In favor of finding a way to use this fund. Reminding the chairs they have this fund. Maybe try to do at least 1 workshop in your term. Maybe it needs to be allocated into each committee so maybe that would make it easier. Remember we are here to make

AA more accessible and to help our fellow alcoholics. We should try to reach out more.

Committees have to follow up with groups requesting workshops. If funds were already there it would be easier to plan

Greeting Area 46! Hope this report finds everyone well and in good spirits. It was great to see everyone in person and on zoom!

The Archives Committee meeting took place at the Area 46 Assembly, August 6, 2022, held in Socorro, NM. Thank you District 3 for hosting the Assembly! The Archives Committee had a total of 15 attendees. 9 of those were in person and 6 people joined in on zoom.

Our first agenda item was to present to the committee a motion to offset the costs in the amount of \$600 for the Archives Chair and the Archivist to attend the 25th National AA Archives Workshop being held in Little Rock, Arkansas on September 22-25, 2022. The motion was passed by the committee. The motion was then presented to the Assembly and was approved.

We discussed the Archives space that is in the same location as Central Office in Albuquerque. The space is in a storage closet and is not a sufficient amount of space to house the current archives materials. The committee discussed how it sees Archives moving forward in finding a new location to house Area 46 Archives. The committee would like to include the districts and the possibility of districts sharing the space for storage of their archives material and possibly contributing to offset the cost of the space. A motion was passed to have a separate meeting prior to our next assembly. At that time, we will discuss and get input from the districts on how and if they would like to see their archives collections to be included in the Area display. Berna, Area Archives Chair will send out an invitation to the District Archives Chairs, committee members and the district DCMs, if there is no Archives Chair for that district, and set up a meeting time before our next assembly to discuss in further detail.

The Archives Mission statement was read, and the group reviewed what items are to be collected. Group histories were encouraged. Referencing the Archives Workbook, Guidelines and Policies for Area 46 was also suggested. The Group History Form will be uploaded soon but copies may still be printed from the Area website nm-aa.org. The available archives presentation list, the Jeop-AArdy game and items available to Districts are also on the website.

Michelle, Area Archivist has continued her work on scanning and digitizing archive materials. Recently, she scanned 2 Spanish language articles that were featured in EL Nuevo Mexicano regarding the starting of AA groups in New Mexico in 1948 and 2 Spanish language letters from 1946-1947. She sent copies of those items to myself and to the Bilingual Chair and Spanish translator Thomas H.

Lastly, out of the Area's 17 districts we have 5 District Archives Chairs. DELETED FINANCIAL SNAPSHOT WENT HERE.

Finance

Well hello fellow financially curious alcoholics.

It's time for another update from the finance chair. We recently had the August Assembly in Socorro NM. I was glad to make it to my first in person meeting since accepting this service commitment (personal reasons keeping me from being in person back in March).

The Finance committee is tasked with presenting a balanced 2023 draft budget which, unfortunately I was unable to do. There are a couple of factors leading to my inability to balance the 2023 budget. As I was working on the 2023 budget, we were only 6 months into 2022,

and only having partial numbers for 2022 and then forecasting, not only what we *might* spend in the remaining half of 2022 but creating a budget based on numbers averaged across three years (2 of which were «Covid» years, that affected the average contributions). the numbers just didn balance. Being new to the finance chair I wasn't sure exactly how to handle the imbalance and based off the three-year average I was foreseeing a substantial shortfall coming in 2023.

This information was presented to the committee during the two financial committee meetings at the August assembly. Many options were discussed, from proposing ways to reduce trusted servant expenses to making pleas to the area/groups for higher contributions. By the time we were having this discussion more information and contributions had come in but had not made it into the calculations of the draft budget. That information pointed to a prediction of contribution levels much closer to the pre-covid years versus covid years. The committee also recognized that the wording in the A.I.P. kept the finance chair from being able to adjust the average to keep a more normalized average during exceptional time like 2020 & 2021 (a.k.a. the 'Covid Years'). The committee asked and voted to make a motion to amend the verbiage in the AIP to allow future finance chairs to adjust the 3 year contribution average in exceptional times, such as the covid years which caused a non-standard average.

Said motion was made, seconded, and added to the Sunday agenda to be voted upon.

When it came time to vote I personally was not in support of the motion and ended up sharing a minority opinion as to why I was in opposition, which as the person submitting the motion and then voting against it caused a bit of wonder.

The committee made a motion, it was my job to bring the motion to the assembly, and then I was able to vote my conscious. I did not think through all of the ramifications that action might have, but I felt that this was the right way to handle the situation. I apologize for the confusion and really had no intention of undercutting the committee of which I am the chair.

As to the budget, things are not as bleak as originally thought going into the assembly, and I will diligently stay up to date on the area expenses and will have much more to report in December in Carlsbad. Anyone interested in the financial position of the area is **URGED** to attend the Finance committee meetings every fourth Thursday of the month from 7:30 pm until 8:30 (ish). Said meetings are easily found on the area website Events calendar.

On another note, and with a huge request for help, progress is being made on the tax-exempt status of the area and much support and more input is needed by the Area, Districts, and Groups. Again, please join the monthly finance committee meetings on the fourth Thursday of each month at 7:30-8:30 pm. We may need to start up a sub-committee to accomplish this. I have asked for a little more time (Through the December assembly) to see if the participation in the finance committee becomes strong enough that we should be able to handle this without a special subcommittee. Only time and participation will tell.

It was great to see so many of you at the recent Assembly in Socorro. Here is the report from our meeting there:

First a big thank you to Eloy and Debra for attending and speaking about the activities and issues concerning the Literature Committee at this year's GSC. We opened at 9:55 am and did introductions. There were 33 members present in person and on Zoom.

Eloy then spoke about the 22 agenda items, actions, and votes that the Committee was involved with at the Conference. He told us up front that he was going to tell us what the business was, but not the outcomes and instead encouraged everyone to support our respective Districts by attending when he comes to give his

full report.

He explained the different processes and discussed some of the highlights in the "never ending request to make all of our literature accessible in all formats". The one item I did ask him to elaborate on was the agenda item he had assigned our committee for the Pre-Conference Assembly, which was revisions to the original pamphlet "The Twelve Traditions Illustrated" that some members find offensive by today's standards. Our Committee ultimately recommended that the pamphlet be retired in favor of the first attempted revision that resulted in a new pamphlet entitled "Experience has Taught Us" (which I have available in English and Spanish). The final vote at the Conference on the matter was to keep the original pamphlet with minor revisions.

Eloy referred back to our Area 46 website and the calls for stories there for several projects, including the 5th Edition of our Big Book. That project is underway and is going to follow with prior editions by keeping the Forwards, the Doctor's Opinion, the original 164 pages, and Dr Bob's Nightmare, while adding a new forward, some new stories, and new appendices. We all have the opportunity to submit our stories for consideration through the link on our website or at AA.org.

After questions by some committee members, I asked Eloy and Debra to discuss a little bit about the process of motions and changing or developing new materials. Debra also discussed the literature shortages, along with the economic factors and supply chain issues that have contributed to delays in literature availability, after which I read two excerpts from "The Literature Committee" in Concept 11 and then we closed with the Responsibility Statement.


