His/her voting status as Chairperson is limited to the period of time she/he serves in this position. Motion by Danny F D12 2nd by Rebecca S D14 for 22 against 46 Minority opinion was given no revote motion fails

Motion by Lawrence M D14 to change name of Special Needs Committee to Accessibilities to be consistent with GSO Second by Steve V D18 1 opposed no minority opinion motion passes

Motion to purchase Quick Books Financial Software for the incoming Area 46 Treasurer Total cost is \$202.00. Money to come from the Contingency fund. Motion by Ally T D12 2nd Steve V D18 motion passed no opposition.

Motion: Funds in the amount of \$836 which have been transferred to Area 46 by the Assembly Development Ad Hoc Committee, shall be set aside by the Area as "seed money" and used to underwrite a Service Forum to be held not later than December 2019 Motion by Kristina F D2 2nd by Juliette D2 for 23 against 54 minority opinion was expressed motion to Lynn K D2 2nd by Gina A D10 35 for against 50 no revote motion fails

ASSEMBLY MEETING REPORTS:

Committee chairs will submit their reports to be published in the January El Farolito. All who presented reports thanked the Assembly for their support and welcomed the new incoming chairs. Summary of the following are presented as they do not appear in the El Faroltio.

GSR Report: presented by Laura D18. Great attendance of both outgoing and incoming GSRS/ Outgoing GSRS shared on what they liked, what they wish they had done different. They talked about the importance of tabling motions, not to take ourselves so serious. Some felt that it was difficult to serve as GSR and have a position at District. They discussed whether it might be time to reestablish the position on Convention Liaison especially to assist some of the smaller Districts. They are all looking forward to the State Convention.
