Informed Group Conscience The "group conscience" is the collective conscience of the group membership and thus represents substantial unanimity on an issue before definitive action is taken. This is achieved by the group members through the sharing of full information, individual points of view, and the practice of A.A. principles. To be fully "informed" requires a willingness to listen to minority opinions with an open mind. On sensitive issues, the group works slowly — discouraging formal motions until a clear sense of its collective view emerges. Placing principles before personalities, the membership is wary of dominant opinions. Its voice is heard when a well-informed group arrives at a decision. The result rests on more than a "yes" or "no" count — precisely because it is the spiritual expression of the group conscience. The term "informed group conscience" implies that pertinent information has been studied and all views have been heard before the group votes. Does signing papers, court/medical/probation officer. Violate any Traditions?
 Specifically, 3- desire to stop; and 12- Anonymity.

Can a group refuse to sign papers? Thank you for your service, Love you.

Response: Laurie- yes & no, there is no violation of Tradition, this is an outside issue. Anonymity protects the person signing any papers. The group has a Group Conscience to help make these decisions.

2) At Assembly time can El Farolito include a page for the Responsibility and Unity Statements, the 12 steps, 12 traditions and 12 Concepts?

Response: Candy, El Farolito Editor- This is a good idea. In looking at past issues of El Farolitio the one Tradition listing has be included in several issues. Printing one page for all of these in a single edition would drive up the cost. Printing the Responsibility and Unity statement in every issue would be reasonable. Adding the one Step, Tradition, and Concepts could be done each month and would be more cost effective. If, on occasion, there is a spare page (like just 19 pages) this would be feasible for the Assembly issues and will be looked at. The pages have to add up to increments of 4 for the proper size and folding.

3) What can we do with old Bilingual interpretation equipment without breaking AA tradition?

Response: Nevin D-9- Either we keep them, sell them or throw them in the trash. If we are donating or selling, we caution on breaking traditions. You try to follow the traditions, how it feels to each individual matters, we caution that we don't affiliate we support and refer to traditions to make the best decision and if wrong, the Area group conscience can bring an informed decision and if I'm wrong I'm not a tradition expert.

1) ¿La firma de papeles, tribunal / médico / oficial de libertad condicional. ¿Viola alguna Tradición? Específicamente, 3- deseo de parar; y 12- Anonimato.

Respuesta: Laurie- sí y no, no hay violación de la Tradición, este es un asunto externo. El anonimato protege a la persona que firma cualquier documento. El grupo tiene una Conciencia de Grupo para ayudar a tomar estas decisiones.

2) En el momento de la Asamblea, ¿puede El Farolito incluir una página para las Declaraciones de Responsabilidad y Unidad, los 12 pasos, las 12 tradiciones y los 12 Conceptos?

Respuesta: Candy, Editora de El Farolito- Esta es una buena idea. Mirando ediciones pasadas de El Farolitio el listado de una Tradición ha sido incluido en varias ediciones. Imprimir una página para todas ellas en una sola edición elevaría el costo. Imprimir la declaración de Responsabilidad y Unidad en cada número sería razonable. Añadir el Paso, la Tradición y los Conceptos podría hacerse cada mes y sería más rentable. Si, en ocasiones, sobra alguna página (por ejemplo, sólo 19 páginas), esto sería factible para los números de la Asamblea y se estudiará. Las páginas tienen que sumar incrementos de 4 para que el tamaño y el plegado sean adecuados.

3) ¿Qué podemos hacer con los antiguos equipos de interpretación bilingüe sin romper la tradición de AA?

Respuesta: Nevin D-9- O los guardamos, los vendemos o los tiramos a la basura. Si los donamos o vendemos, advertimos sobre romper las tradiciones.
