7. Motion to facilitate the giving of birthday and gratitude contributions to Area 46 by individual members, a Gratitude Program will be created whereby return envelopes are supplied to Districts, Groups, and Central Offices. The Finance Chair

will be responsible for the Gratitude Program. Section I.F.6.g of the AIP will reflect this addition to the Finance Chairperson's responsibilities. All funds received through the Gratitude Program will go to the Area General Fund.

The following paragraph will be added under V.B.7, p31, as an additional item on the Area Budget: "Gratitude Program- Funds will be budgeted each year to cover printing of envelopes and Post Office Box rental."
