I have been working with the South West Regional Alcoholics Anonymous Service Assembly (SWRRASA) on the Traditions presentation with my fellow Alternate Delegates from our Southwest conference and an opportunity to lead a SWRRASA session on Workshops. It will be held in Rogers, Arkansas at the Embassy Suites October 21st through October 23rd 2016.

Archives

It was great to see other Area trusted servants at the planning committee for the September Area Assembly in Santa Fe. While there, I spoke to Ana and Tom of the Bilingual Committee about documents in the archives that were in Spanish from the 1940s. This week I had the honor of presenting copies of documents from the 1940s to the Bilingual Committee. They were excited to read some of their history and piece together the correspondence in our files and how they relate to early AA meetings in New Mexico. I look forward to their translations.

At the March Area Assembly, I presented the Archives goal from GSO, which was to encourage more group histories be collected. At least three people have contacted me for group history information and I've been invited to hear about the Old Timers group history in October, when it will be presented. It's exciting to hear that others are interested in preserving the history of AA in New Mexico. I will have copies of the "Oral History" packet at the assembly in Santa Fe next month, and look forward to discovering more ways to encourage others to pursue this activity. I met with the Archivist, Olivia, to discuss our path forward in the next few months. We have ideas of how to organize the Archives Room located at Central Office in Albuquerque so the files will be more accessible to visitors and research. We are excited to implement our ideas and continue to improve the archives for Area 46.

I incurred \$34 for copies requested by District 5 since the last Assembly. I look forward to seeing everyone at the Area Assembly in Santa Fe! And as always, I'm available to visit, present or play JeopAArdy – just ask!

Special Needs

In each newsletter I have been sharing on different topics related to special needs and accessibility. This months will be on Sign Language Interpreters:

If there is a need for an interpreter try to arrange to have a sign language interpreter at the meetings that deaf alcoholics attend. The deaf member may be able to bring an interpreter. If not, try to make arrangements through a local agency or check with your local special needs committee, intergroup or central office, general service district or area committee to see if they have any experience with the situation. Qualified interpreters are professional people who charge fees for their services. Experience suggests that most groups will (Continued on page 10)

agree to have a non-AA attend its closed meetings to act as interpreter for the deaf alcoholic. Professional ASL (American Sign Language) interpreters adhere to a strict code of ethics, which assures the confidentiality of the AA meeting.

Some AA groups cover this expense. Sometimes an agency will take care of the expense. On occasion, local area committees, districts, and central/intergroup offices have authorized payment for interpreters. Professional interpreters who are also AA members sometimes are willing to volunteer their services. Occasionally advanced students of interpreting will do the job at no fee for the experience gained. Be careful of placing too much reliance on volunteers, as deaf members rely on these services and there should be stability in whether the meeting is interpreted or not. Experience shared with G.S.O. Indicates that numerous areas have formed Special Needs Committees and this experience seems to indicate that these committees can be a partial solution to funding the cost of signers. Groups are encouraged to contribute and designate funds for these committees. Sometimes a group will pay half of the cost for interpreters with the fund providing the other half. Whatever arrangements are made should be based on a group conscience decision arrived at after full discussion at a business meeting. The interpreters should be introduced to the group before meetings.

I am looking forward to the September Area Assembly in Santa Fe. Please consider attending the Special Needs Committee in efforts to share how your group addressing those with disabilities and special needs. If you have any questions, please contact me.

If you review in the printed ELF the financial report we have a challenge. We had 2 large expenses in August, \$225 to the bulk mail account and a surprise when I found the rolls of 10 cent bulk mail stamps in 3000 were no longer made, the minimum was 10,000. Thus we had \$1,225 in expense in one day.

That is why we are back to a 16 page ELF and it breaks my heart. I will not print 20 pages unless the checkbook balance is above the \$2,500 prudent reserve. We need help. I have lined up an donor to pick up the printing cost this month who wishes to remain anonymous (He is a member of AA) That is a significant donation for which I am grateful. We still need help, that donation just keeps the balance at \$1,269 instead of dropping to \$700 or so.

Under no circumstances will we come to the Area for financial help. So DCM talk to your groups. Groups who have asked for multiple copies that do not donate enough to support the extras will no longer receive them after this issue. We are happy to offer an email subscription for \$3. We will send any group the PDF version that they can use to print as many copies as they want. June 23, 2016 District Nine hosted a workshop on corrections at Laguna Pueblo.

David D. Area 46 Chair for Corrections helped organize the event. Joseph T., Co-Chair

for Corrections, the Northern Region, assisted. More than twenty people were in attendance, the panel was chaired by Jerry F. from Laguna.

David D. opened the discussion by telling his story that led to his being passionate about taking meetings to those who are incarcerated. This led to interesting and heartfelt discussion which centered around why attendees felt that service work in the institutions was so important. Many of those who spoke had gotten the program when it was brought to them while they were serving time. The discussion included the importance of Bridge the Gap, a program which helps connect those leaving prison with someone in AA, on the outside, to guide them to meetings.

Discussion also spoke of how to become certified to take meetings into correctional institutions, and difficulties that may arise with staff and inmates. Also we discussed, at times volunteers can become discouraged and not appreciated for service offered. The consensus was there are those success stories that do continue following the AA principles which make it all feel worth it to continue carrying the message.

Grants women's prison has gone through changes, including a new warden. Volunteers have fallen off, but fortunately Y. B. has stepped up to the plate to re-energize taking meetings into Grants. On July 24, 2016, Downtown Lunch Bunch, held its group conscience, attended by about 20 people.


Group conscience is a vital part of an AA group because its where God's power takes over, and guides us through decision making to reach consensus.


