Dear friends in service,

The AHCAB is in full swing, having now completed our first two Zoom full committee meetings and one subcommittee meeting to consider the various options for handling and distributing the 6,000 pieces of literature we received from Bernalillo Detention Center. Here's an amazing fact: among the books there are 490 copies of a soft cover *Big Book* Second Edition in Spanish!

It's a daunting task to take into account our love of AA literature, the need to distribute it to suffering alcoholics in and outside our fellowship, and to do this efficiently and responsibly.

Our committee of about 19 people, DCMs, area chairs in Corrections, Treatment and Literature, past delegates and Trusted Servants are meeting monthly to discuss the five options sent to us by the prior rotation panel about the books. We meet as subcommittees two weeks before full committee to see what our Traditions and current experience tell us pro and con about each option.

Treasurer

What an interesting spring it has been. We have certainly seen some AA history being made here in Area 46 in the midst of our nationwide pandemic. But we have continued to be responsible as AA members and the hand of AA has always been there throughout this difficult time. Thank you to all of our members.

I'm happy to report that the area finances have not been negatively impacted with any significance. Compared to this time last year, our budgeted income is only down 15%. Though groups have struggled to maintain their own 7th Tradition, much of this decrease can also be explained by a lack of the March Assembly 7th Tradition (typically around \$500) and issues with our old P.O. box not forwarding group contributions (not to worry, this has been sorted out). It's no surprise that our expenses are quite a bit different compared to this time last year. Again, due to the lack of this year's March Assembly, our budgeted ex-

penses are down 51%. And though this was not due to fear or a miserly attitude, we will soon perhaps find ourselves in a position with an excess of accumulated funds. This is an issue that the Finance committee and I will be watching closely in the coming months.



Our district will be presenting a motion at the next assembly so that GSRs, DCMs, and Area members can become informed on the topic and discuss with their groups. Area discussion and vote will take place at a subsequent assembly.

Motion: That Area 46 adopts the practice of the General Service Conference and require substantial unanimity, that is, a two-thirds majority to change policy. Procedural matters will continue to be decided by a simple majority.

Background: In the past, Area 46 has made decisions without substantial unanimity, which has led to members questioning our voting procedures. Pages from the General Service Conference Communications Kit regarding How the Conference Operates define substantial unanimity as a two-thirds majority. Other areas throughout the United States and Canada were also consulted for guidance. Nearly all who responded set a similar or identical precedent. Most of the proposed changes to the AIP borrow language directly from the General Service Conference Communications Kit on How the Conference Operates. It is the conscience of District 13 that aligning our voting procedures with the General Service Conference would lead to greater unity among Area 46 and its members.

District 13 intends to put together a bid to host a 2021 Area 46 Assembly, however we have tabled discussion until venues are open to communicating about booking space for large gatherings. In the interim, if you have any suggestions for a hosting venue in Albuquerque (S. of I-40 & E. of I-25), Tijeras, Moriarity, McIntosh, Willard, Mountainair, or Corona, please email district13@nm-aa.org.
