ill L., alternate delegate, and I attended the Southwest Region Delegate Assembly (SWRDA) on March 8 – 10 in Oklahoma City. We were joined by delegates and alternate delegates, past delegates (including four from Area 46), the current SW regional trustee and past trustees from around the region. In all, around 90 people from 11 areas showed up for the purpose of discussing topics related to AA Service and helping to prepare the new delegates for the General Service Conference. There were presentations and a mock conference using agenda items from past conferences. There was no discussion about the current conference agenda items; everyone's focus remained on procedures and general topics. As a second-year delegate, I got to share my experience, strength and hope with the first-year dele-

gates. It was a good feeling to be able to "pay it forward."

I would like to start some in-depth discussions about the Communications Audit that was commissioned by the General Service Board (GSB) in 2017 and 2018. The GSB has spent nearly \$400,000 on this project to date and has budgeted another \$187,000 for 2019. The full report of the Communications Audit was more than 300 pages. The GSB has given us an abridged report that is less than 30 pages long (the results begin on page 11 of the abridged document). The GSB is using the Communications Audit to guide their decisions. I believe it is vital that we be aware of what it says. Furthermore, if there is useful information in the report, I think we should use it in our service work in Area 46. I have posted the abridged Communications Audit Report on the delegate's webpage at https://nm-aa.org/trusted-servants/delegate/. I would be happy to hold workshops or come to your district meeting so we can explore this report together. I will have time in April and early May – please call.

Speaking of reports, it's time to schedule delegate reports of the 2019 General Service Conference. My first report will be given at the Area Convention in Santa Fe. DCMs, please call to schedule a delegate report for your district. Once again, Bill L. will be available to give a service workshop before the delegate report. For those of you who heard the Service 101 workshop last year, Bill is preparing a Service 201 workshop for this year.

Delegada

ill L., delegado suplente, y yo asistimos a la Asamblea de Delegados de la Región Suroeste (SWRDA) del 8 al 10 de marzo en Oklahoma City. Nos acompañaron delegados y delegado alternos (incluyendo 4 del Área 46), el actual Custodio Regional de SW y custodios pasados de toda la Región. En general, alrededor de 90 personas de 11 áreas se presentaron con el propósito de debatir temas relacionados con el Servicio de AA y ayudar a preparar a los nuevos delegados para la Conferencia de Servicios Generales. Hubo presentaciones y una Conferencia simulada usando temas del programa de Conferencias pasadas. No hubo discusión sobre los temas actuales del programa de la Conferencia; el foco de cada uno permanecía en procedimientos y asuntos generales. Como delegada de segundo año, pude compartir mi experiencia, fortaleza y esperanza con los delegados de primer año. Era un sentimiento bueno para ser capaz de "pagarlo adelante".

Me gustaría empezar algunas discusiones en profundidad sobre la auditoría de comunicaciones que fue encargada por la Junta de Servicios Generales (JSG) en 2017 y 2018. La JSG ha gastado casi \$400,000 en este proyecto hasta la fecha y ha presu-

puestado otro \$187,000 para el 2019. El informe completo de la Auditoría de Comunicaciones fue de más de 300 páginas. El JSG nos ha dado un informe abreviado que tiene menos de 30 páginas (los resultados empiezan en la página 11). El JSG está utilizando la Auditoría de Comunicaciones para guiar sus decisiones. Creo que es vital que estemos al tanto de lo que dice. Además, si hay información útil en el informe, creo

Our delegate Teresa J. and I at-

tended the 2019 SWRDA (Southwest Regional Delegates Assembly). It was held March 8-10 in Oklahoma City in preparation for the 69th General Conference. This is an annual assembly by our SW Region to provide preparation for the delegates who are about to head for the upcoming General Service Conference. Alternate delegates also attend as part of their preparedness to serve, if called upon. This year there were approximately 82 in attendance. Our Southwest Region is highly dedicated to the preparation of our delegates and invests a lot of effort to support them. This year approximately 60 past delegates and past trustees gave of their time to participate. We had four past delegates from Area 46 attend. Many wonderful presentations were given, and there was a mock conference break-out session Saturday afternoon. Additionally, introductions were held for the 11 SW regional trustee nominees, including our own Lori P. from Area 46. This assembly is a most humbling experience. It is an honor to receive support from such a wide variety of trusted servants who care so much about our beloved program.

The Alternate Delegates committee meets twice a year. We met at SWRDA in March. In 2019, Kansas Alternate Delegate Sherri P. serves as chair of the committee, and I serve as secretary of the committee. We elected the officers that will serve the Alternate Delegates committee in 2020. Our committee is reviewing the SWRAASA Guidelines.

The New Mexico AA Service Forum (NMAASF) will be held July 20 at St Thomas Aquinas Church in Rio Rancho. Planning continues. District 18 is doing a wonderful job of preparing for the forum. We have a Guidelines subcommittee working on a section to be included in the AIP for future New Mexico AA Service Forums as well as a set of "suggested guidelines" which provide some more specific recordkeeping of the processes used in the previous two service forums.

District 2 CPC chair Juliet, while gone for a good portion of last month, kept the home CPC fires burning with her committee putting together digital contact lists and creating confidential Google docs for the team. COMMITTEE CHAIRS

Finance

This month, I'd like to talk about the General Service Conference (GSC) agenda items our delegate has asked the Finance Committee to weigh in on. The two items are: 1) Review suggested area contribution for delegate expense for the conference. 2) Review report from GSO's general manager on GSC site selection. Both these items are actually pretty closely related even though the second one is for the Policy/Admissions committee to review.

I think the site selection question has been primarily sparked as a result of the rising costs of the conference overall as well as the significant difference in cost between the two current sites (in 2018, it cost up to \$400,000 more to hold the GSC in the city of New York than it would have cost at the alternative location, according to a letter from the GSO general manager). It is these rising costs then that bring us to the other agenda item regarding the area contribution for delegate expenses for the conference.

Would this significant increase in conference costs require an increase in the area contribution? Would changing the site of the GSC to a less expensive venue stabilize the area contribution? There may be simply management issues such as why, when it was affirmed that the conference be held outside New York (in Rye) every other year, four of the last five conferences have been held in New York costing about 45 percent more than Rye. If the conference site was alternated every other year as planned, overall expenses would be reduced and the Conference Committee might not have to consider raising the area contribution. At any rate, the review of the site selection process is slowly happening and can be urged forward by not throwing money at the problem by just raising the area contribution amount.

The 2019 GSC will be May 19-25 so there is still time to talk with your home group about this and pass on your thoughts to our delegate, Teresa.

District 7 ARTESIA, ROSWELL ...

It has been a little exciting for the most part this week. Our neighboring town south, about 18 miles, Dexter, had a tornado March 12 that did major damage and really tore up a couple dairies. In August, Districts 14 and 15 will hold their annual weekend campout. It will be held at Lake Abiquiu. Details to follow.


