Each gave a recap of what they saw and what they heard, and what they felt while at SWRAASA. I think it was very informative for everyone who came to the evening event. Again, I thank each of you for supporting SWRAASA this year. Unlike regional forums, where GSO is responsible for the content of the Forum, the Southwest Regional AA Service Assembly is put on by the 11 areas in our region. As such, we, the 11 areas, are also responsible for the content of the service assembly. Each area contributes speakers and presenters to support the event. The group that we had in Branson represented Area 46 with stellar performance. We can all be proud of them for their service to our area and to our region.

The AA 101 workshop has now been presented in Districts 1, 2, 4, 6, 7, 8, 10, 11, 12, 13, 14, 16, and 19 – two-thirds of the districts. I believe that it was successful enough that a second version will be offered next year. More shall be revealed sometime after the 69th General Service Conference in May.

The New Mexico AA Service Forum (NMAASF) will be held in July of 2019. Planning continues. Planning meetings are held the 3rd Thursday of each month at the Bernalillo United Methodist Church, 136 Don Andres, Bernalillo, NM 87004 at 7:00 p.m.

Every 22 years, the SW Regional Forum comes to Area 46. The last one was in 2001. The next one is in 2023. As with a lot of things in AA, they go

slow, and need to be planned early. Area 46 confirmed that we will take our turn in the rotation for 2023 at our December Assembly. Thank you, Area 46. I will be creating a site selection committee during the first part of 2019.

December afforded an opportunity to attend a Christmas potluck in Taos in District 14. January already has something planned for each of the Saturdays. I will be participating in a workshop in Roswell in District 7 on January 12th, and attending the 3 Legacies workshop on the 19th, and the Safety workshop on the 26th. I am so proud of all of the service work and workshops that Area 46 puts on. You guys carry the message so very well in our area.

Minutes of December 2018 Area 46 Assembly

SATURDAY DECEMBER 1, 2018

Meeting was called to order by Rosie F.. Area Chair, at 8:30 a.m. After a moment of silence, followed by the Serenity Prayer, there was a reminder to sign the Big Book that will be going around. Eloy also mentioned about the Ask It Basket, the AIB in English and Spanish and where they were available.

Rosie F., Area Chair, made housekeeping announcements and explained where committee meetings would be held

8:45 a.m. – 12:35 p.m.: Committee meetings as well as GSR orientation, GSR, DCM, Trusted Servants and past delegates meetings.

1:45 p.m.: BUSINESS MEETING

Afternoon Session was called to order by Eloy M., Area Chair. Jerry T. (D6) read the Preamble. There were readings in both English and Spanish from *As Bill Sees It*. Jerry F. (D9) read in English and Edwin L. (D17) read in Spanish, followed by introduction of all present, including seven first time at Area Assembly.

Secretary's Report: Presented by Ana G., Area Secretary. Summary of minutes from March 2018 Assembly (D7) Roswell. Minutes were approved as submitted.

Treasurer's Report: Ally T., Area Treasurer. Ally explained her report which was provided as a handout. As of November 30, 2018 the amount of contributions has increased 6% compared to

November 2017. The number of groups sending contributions has decreased 14% compared to 2017. This means that groups are contributing more, but fewer groups are contributing. Kurt K. made motion to accept the Treasurer's report, Tim G. seconded it. Treasurer's Report accepted.

Registrar's Report: Presented by Kurt K. Asked if GSRs are getting emails. It is important that groups keep their GSR or group contact info updated – including mailing and email address changes – so the group will continue to receive mailings from GSO (like Box 459) and from Area 46.

Delegate's Report: Presented by Teresa J. The GSB commissioned an audit of our internal and external communications to see how well we are communicating within our Fellowship and to the public. The audit began in 2017 and was completed in 2018. Anyone is welcome to read a summary of the report at *nm-aa.org/trusted-servants/delegate/*. Area 46 played a role at SWRAASA October 5, 6, 7 in Branson, MO.

Alternate Delegate's Report: Presented by Bill L. Every 22 years the SW Regional Forum comes to Area 46 the last one was in 2001. The next one is in 2023. He will be making a motion in this assembly and to confirm that we will be taking our turn for 2023. The next guidelines subcommittee meeting is December 13, at 7:00 p.m., United Methodist Church, 136 Calle Don Andres, in Bernalillo.

General Area 46 Announcements: Announcements were made of upcoming events. Fliers are available on table near registration. Announcements of A.A. Events can be found in *El Farolito* and at nm-aa.org.

Cooperation with Professional Communities

Happy New Year Area 46 AAs,

Cooperation with Professional Communities (CPC) continues to be a valuable and wondrous service opportunity in AA – never done, that's for sure – but every inroad carries with it the possibility that one more alcoholic might find AA and sobriety.

Ron in District 8 continues to meet with drug courts and "clients" to carry the Big Book message there. They're making connections with judges, probation, lawyers and medical professionals. Barbara C. in District 15 is getting the word out to teachers in Los Alamos. Jack M. in District 13 has a committee that is actively getting the word out to many different professionals, and adapting the form letters from the CPC workbook and the "Does your Doctor Know" that Bill L. (alternate delegate) wrote years ago when he was

CPC chair in Florida, for members and groups use to educate professionals. A member of Juliet and Brian's CPC /PI committee in District 2 facilitated a public service announcement about AA that's now airing. An AA at the assembly said she'd heard it and was very moved by it. A doctor from Las Cruces called for information about AA, and Julio, the District 4 DCM, is getting in touch with her to see what she might need and what other professionals might want information about AA.

The assembly CPC break out session went well. Until now we've been focusing on what to say to professionals and really using the Preamble as an initial tool. Now we're focusing on who to talk to, how to make those connections and how to prepare a presentation. Those attending the breakout session came up with some great insights and ideas. Chris from

District 10 mentioned that he knows how to talk about AA but doesn't have the connections with professionals, and realized that the connection may be sitting right next to him in an AA meeting. So he's got to get the word out that he can make those presentations. Maggie, District 8 DCM, and Jeffrey from District 15 are interested in a workshop for groups of professionals with whom they are in contact. What an inspiring group! It takes courage to reach out to professionals and get outside your comfort zone. Congratulations and thank you for your service.

I look forward to seeing you in 2019 and launching into some new CPC adventures. We are not a glum lot!

Finance

Our primary accomplishment for the Finance committee and the assembly as a whole was the approval of the proposed 2019 budget. Though a few challenging questions were raised and some astute observations made, the presentation was painless and the committee would like to thank the assembly for its approval. Honestly, I appreciate the questions; it shows me you're paying attention! One significant change made by the finance committee was the increase in assembly hosting to \$1,200 for each hosting district. This increase was suggested based on input from past hosting districts stating the current budget amount was not covering hosting costs and these districts were having to fund the shortfall. The last time the area approved an increase was 2010 when assembly hosting (then "assembly seed money") went from \$800 to \$1,000.

The finance committee also discussed possible financial concerns

with the printing of the El Farolito Assembly Edition. Currently, the area pays \$450-550 per year to print and have available copies of El Farolito at every assembly. While the original question was "why are we paying for something most assembly members are already receiving in the mail?" the issue evolved into whether the assembly edition ELF is fulfilling its intended purpose and, therefore, is the area (and ultimately the groups) receiving the full value of this expense. Mind you, this is not an El Farolito problem but rather appears to be a communication problem within the assembly and the area as a whole. It's an issue I encourage all the GSR's to look into.

Finally, I'd like to return to the topic of assembly hosting and address a matter that has come up. Many of us in the area don't realize that when a district receives the bid to host an assembly, usually up to one year before the actual date, the

area treasury immediately cuts a check for the full budgeted amount. Consequently, the assemblies occurring next year are typically funded by the current year budget. In the case of the 2019 budget, with the assembly hosting increase, it will be funding the assemblies occurring in 2020. The issue is should the increase apply to the 2019 assemblies too, and if so, how can we make that happen? Only our experience and the experience of those who came before us will reveal the truthful path to take.

Thank you District 10 and Carlsbad AA for a wonderful assembly.

Hello Area 46,

I can't believe it's already the end of the year, and looking forward to my next year of my rotation.

I started the committee meeting with a moment of silence followed by serenity prayer. There were 30 persons in attendance in the meeting. At our assembly planning meeting in November we were asked how can we get the newcomer involved in the assembly. Someone mentioned that in our committee meeting we should ask if anyone is a newcomer. I did, and there was: Harolsen Y. from District 9. I asked him if he would take notes for me and he agreed.

I shared how the "pink can" was doing and how much was donated from groups (\$823.12). This allowed purchase of three cases of Big Books and pamphlets to give out at the assembly for everyone to take back to their groups.

We then broke up into three work groups to discuss:

(3) What would you like from me on my last year of my rotation to be of better service as your correction chair? Attend district meetings, better communication, provide a current list of contacts at each facility, have a monthly conference call with all members, provide basic training.

We ended the meeting by sharing about each topic.

It looks like I'll be doing some traveling to different districts this coming year, so call me when you would like for me to attend your district meeting. On Sunday morning, Harolsen shared my minutes with the assembly and he did an awesome job. Thank you for your service!

Assembly was adjourned until March 30-31, in Grants, hosted by District 9. Closed with the Responsibility Statement followed by the Third Step Prayer.


