I hope this email finds you in good spirits and good health. The biggest news in this report is the cancellation of SWRAASA - the South West Region Alcoholic Anonymous Service Assembly which was to be held in Amarillo, Texas and hosted by Area 66 (Northwest Texas) on October 9-11. After many meetings and deliberations the event planning committee chose to cancel. I personally know of the work that went on to put on a SWRAASA. Area 46 hosted it back in 2012. The Chair was chosen four years prior and the committees followed suit a year later. It took three years of work to put on a SWRAASA. And that is the same amount of work and time the Area 66 SWRAASA Committee put into hosting theirs, The Southwest Region is made up of 11 Areas in seven states. SWRAASA is rotated every two years by the 11 states making it 22 years for Area 66 to be able to host again. So I am sad for them. They also decided no virtual meeting would be held. As a member of the Southwest Region Alternate Delegate Committee, we had quite a few conference calls with the SWRAASA committee during the last few months and I personally know this was not an easy decision to make.

On another note, the 2021 Area 46 Service Forum Committee is up and running – for now we meet on the second weekend every month with the next meeting occurring during the September Area 46 Virtual Assembly. Happy assembly month, Area 46! As I write this I'm looking forward to our first full assembly presented virtually. While this *El Farolito* issue will be the one available at the assembly, the included financial report is not the one I'll be presenting at the assembly as I will have the September financials available by then.

At this assembly, I hope to make a motion in cooperation with the Finance committee to create a way for the area to accept online contributions from our groups and members. This would most likely go through our area website in conjunction with a third party payment service, such as PayPal or Venmo. I believe that this motion will solve the issue of our 7th Tradition collection at virtual assemblies as well as provide a convenient method for contributing to Area 46 at any time.

The recent decision to cancel the SWRAASA event scheduled for October has significant financial implications to Area 46. Our 2020 budget included expenses related to SWRAASA totaling \$3,500. Add this to the unspent \$7,400 budgeted for the March and September assemblies and we're looking at a significant

amount of projected available cash at the end of 2020. While I don't believe the area is necessarily "accumulating funds for no stated AA purpose" as Tradition 7 warns us against I do see the threat of "futile disputes over property, money, and authority" affecting our spiritual heritage. This is an issue I would like the groups to be keenly aware of and hopefully we can start to mitigate the situation sooner rather than later.

# Ad Hoc Committee About the Books

Our committee continues to do its work on helping the Area decide what to do with the 6,000 pieces of literature from Metropolitan Detention Center. We have had active pariticiation from District 17 and the Bilingual committee as well as several of our DCMs, Trusted Servants and other committee chairs. Teresa J. and Ray R. continue to give us "trusted elder" advice. So far we have looked into four of the five options set out by the previous book committee: Distribute the books to Corrections and Treatment: Distribute the books to those committees which express a need; Distribute the books equally among the districts; and Distribute the books to those districts which do not have a Central Office so as not to adversely affect Central Office income. We have one more to go: Distribute the books to the districts proportionately, and we will take a look at that option this month. Our work isn't done, though! We need to take a longer look at the best way to distribute the 2,400 pieces of Spanish literature. There may also be combinations of the five original options which will work better than any particular one. We need to imagine practical issues like how to actually, physically distribute the books. So we will not have a final recommendation before December and it may take a bit longer. Rest assured, however, we are looking carefully at each option and measuring it's practicality and harmony with AA Tradition.

We will have a full Assembly committee meeting in the third time slot on September 12. Please join us if you have questions or want more information.

# Bridge the Gap

Greetings and well wishes Area 46!

Over the past couple of months, I have received a couple of out-of-state referrals for folks returning to the Land of Enchantment from treatment facilities. It was good to have the opportunity to help out. Other than that, one might say "business is slow." However, there may be opportunities out there.

As always, our work is primarily contingent on AAs access to, and relationship with, Treatment and Correctional facilities. Given the

current state of restrictions, I would encourage all who are engaged in our efforts to reach out to those facilities in your district to see how we can best serve them. Are they participating in Zoom meetings? Can we provide them with Bridge the Gap referral cards, either hard copy or digitally? What timeline do they anticipate allowing access for in-person meetings? Can we provide literature? Do they have information on how to use the Meeting Guide app? I believe some of these outreaches may produce fruit.

#### Host

#### **Registration Room**

We will have a breakout room open for registration-related issues. Everyone will be registered ahead of time, but this is the place to go if you need help renaming yourself or have need to talk to our Area 46 Registrar. Please ask the Host via chat to move to the registration room.

#### **Tech Admin**


