### Trusted Servants

### Delegate...

One of our greatest treasures is our experience to be shared and learned from, and good communication is the key. The A.A. Service Manual says that "Good communication is of vital importance. In personal Twelfth Step work, there is no end to communication. The sponsor talks with the drunk; speakers share their experience; we share with each other. But when it comes to general service work, communication has a tendency to break down. It can take hard work to get the attention of alcoholics, but with a creative approach, they can be encouraged to take time out from the nuts and bolts of recovery to think about another phase of their new lives. Once A.A. members become well informed about service, they often want to become involved and take on their own service responsibilities."

Communication will be the theme at the March "Pre-Conference" Assembly. Each of you will be given the

#### Why Do We Need a Conference?

The late Bernard B. Smith, nonalcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting: "We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.

"We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we

need it to protect A.A. against disintegration while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

"We need it to ensure that changes within A.A. come only as a response to the needs and the wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

### Registrar...

"our membership ought to include all who suffer alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend on money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group." This clearly implies that an alcoholic is a member if he says so; that we can't deny him membership; that we can't demand from him a cent; that we can't force our beliefs or practices upon him; that he may flout everything we stand for and still be a member. In fact, our Tradition carries the principle of independence for the individual to such an apparently fantastic length that, so long as there is the slightest interest in sobriety, the most unmoral, the most antisocial, the most critical alcoholic may gather about him a few kindred spirits and announce to us that a new Alcoholics Anonymous group has been formed. February typically is very busy. Starting with creating the mailing of the Area Assembly Flyer and Agenda. Hopefully everyone received their copy, either electronically or by paper mail. Late in February, the directory information was downloaded from the National Database, and our Area 46 Directory was created, both in English and in Spanish. Advance orders were taken from those receiving directories to determine how many paper copies were going to be necessary. Because many the Trusted Servants are OK with PDF version of the Directory, our Area printing costs are significantly less than in the past.

The Downloadable PFD Group Information Forms and New Group Forms on the Area 46 website were all reviewed and modernized to request all of the pertinent information for the National Database and the online web based schedules.

Expenses to date are \$49.00 for postage to mail Area Assembly Agendas and Flyers and another \$36.79 for supplies. Final costs for printing the Area Directory are not yet available, but are estimated to be very similar to last year at approximately \$150.

We are happy to have completed the Special Needs first year as a new "Standing Committee" thanks to the support from Area 46. It is the Committee's goal to help pave the way for A.A. members with special needs to reach and participate in A.A. meetings, or to arrange to have A.A. meetings brought to them. 
### How to Make an Assembly Motion

#### CPC in Action...

Over the past 25 years, the court system has been referring people in the system to Alcoholics Anonymous meetings, in hopes of reducing the high incidence of alcohol related offenses in the Farmington area. Recently, some members of AA approached District 8 with a proposal to provide classes to people on probation as an alternative to having them 'sentenced' to attend meetings. A series of classes, based on other working models from other areas, would be presented in a venue provided by the probation system and with attendance verification being monitored by court personnel, rather than an AA member signing off on a court slip. After several meetings with the Drug court manager, spirit of rotation and a change in management in Drug Court, the PI/CPC chair was able to meet with the new manager. Willingness was the key to unlock the door; a committee was formed with District 8s PI/CPC chair and up to 10 volunteers from the District. An outline for the classes was created and approved by the committee.

The classes were set up to be a 7 week series, covering the following topics: 1. What AA is and is not. 2. The Doctor's Opinion. 3. There is a Solution. 4. The 12 Steps. 5. The 12 Traditions. 6. Sponsorship and 7. An AA Member's Personal Story. This is a panel meeting with two presenters per class, held at The Well, our local recovery club, in a classroom style setting with tables and chairs. Drug court pays the rent for the meeting room and signs the participants in before the class starts. Class sizes range from 6 to 20 in a one hour period. The classes give participants information that could take years to learn just going

to meetings, helping them make an informed decision on whether A.A. is for them.

Though there is no way for us to monitor how many people continue to go to A.A. or how many actually complete the Drug court program the results have been positive; the seven-week series has been presented to Drug Court for nearly 5 years, with a much larger percentage of clients choosing to pursue recovery. The program has created a spin-off panel that presents a similar message to clients in Intensive Out Patient counseling. With the venue set up and paid for by the counseling agency. A panel of 6 presenting to 50-55 patients in a theater style setting. The panel uses "What A.A. does and doesn't do" "The Twelve Steps" and "Sponsorship" in a two hour time slot.

While not eliminating the problem of unwilling attendees in meetings, because of court papers and not having a choice of attending meetings, getting all of the various arms of the courts on board, there has been, overall, a great response to the efforts here. The ultimate goal remains to see AA meetings focusing once again on helping the still suffering alcoholic, while the courts focus on compliance. In the meantime, the committee is satisfied with accepting progress, not perfection.
