#### Delegate Report

It was great to see everybody at the March Assembly in Albuquerque. Thank you, District 11, for hosting! Especially helpful to me were the Evening Sharing Session on topics selected from the agenda for our 2015 General Service Conference and the discussion on Saturday afternoon about the purpose and cost of the conference. I've also had the opportunity to hold workshops on Conference agenda items in Alamogordo and Albuquerque and I hope to schedule a third workshop in the northern part of Area 46. Your insight and experience are essential to me as I prepare for the Conference. One motto I take with me is that a delegate should go to the Conference informed but not instructed. That is, each delegate should try to get a sense of the concerns and wishes of the groups in their area, but not be bound to vote a particular way, in keeping with our Third Concept, which affirms our Right of Decision at all levels of service. Although I am a member of Area 46, I am sent to the Conference to represent AA as a whole.

At this year's Conference we will be completing our three-year inventory process, which will be presented in an inventory report coming out later this year. We will also be electing a new Southwest Regional Trustee, to begin a 4-year term immediately after the conference. The new trustee will be our guest at the September Assembly in Belen.

We often hear in AA that this is a selfish program, and it's certainly true that working with others helps keep us sober and enhances our lives. But I also try to keep in mind that the book *Alcoholics Anonymous* refers this as an *altruistic* program - a selfless program directed toward helping others. If I work with another alcoholic with the attitude that it's all about me, the experience will be of little benefit to either of us. In any type of service, it is dangerous to presume that the only thing that matters is that it's keeping me sober. I have to approach each service opportunity as the sacred trust it is, making every effort to share the life-saving gift of sobriety, yet

I have to keep focused on my true purpose, which is to be a responsible member of Alcoholics Anonymous and to try to make decisions that will be benefit AA as a whole. If I happen to have a life-changing spiritual experience in the process, so much the better! But even without that, I'm grateful for this opportunity to be of service.



Once that was done, I emailed the GSO/FNV file to my technical support (thank you!!!) for formatting. I'm now in the process of reviewing that document for any "tweaking" required. #### **Treasurer**

The March Assembly was just fantastic. Thank you District 11 for hosting us. I seem to leave each Area Assembly filled with overwhelming gratitude for those who have gone before me and for those who currently give so generously of their time to General Service to both carry the message of AA into their communities and to make sure that AA will be around for future alcoholics.

At the March Assembly the Finance Committee determined it would be best to only post general information regarding Area 46 finances on the Area website. Since an electronic version of *El Farolito* is now available on our website, the amount of financial information normally published in *El Farolito* also needs to be considered. Our new *El Farolito* Editor, Jay, generously offered to either remove or print a modified version of the financial table in the web-version of the newsletter. This will be a work in progress as Jay, myself and the Finance Committee figure out what works best. (Thank you Jay for your help and support!)

So far this year (to February 28th), 60 groups have contributed 69 times to Area 46. In addition, the Area received a contribution from NMCYPAA. Expenses have included rent for Archives, one 12th Step event (a PI health fair) and the planning meeting for the March Assembly. In addition, the Delegate Fee for the 2015 General Service Conference was paid in February. This year the Area 46 Delegate Fee was equal to the estimated cost per conference member. It was funded using general funds (as per the 2015 Area budget), all of the 2014 Area 46 Convention overage and available cash at year end (as per the Dec. Assembly). We ended February with available cash above reserves of \$2,473. All of that money (and then some) was spent during the March Assembly.

### Archives Committee

The Archives committee met at the Assembly with 15 people in attendance from 12 Districts. I would like to thank all who attended. After opening with the Serenity prayer and introductions, we had a brief update about the changes to the Archives Display. More background picture boards have been added, there is the addition of the electronic slideshow display on our donated display screen. Additionally, more local NM histories are re-printed and available as display items. If you have an opportunity, please stop by and see our display. Also, on the Area Website, Archives Committee page, I am now posting a couple of NM historical facts each month, so please visit the Archives web page and check out some NM history.

We briefly discussed requesting "Group Histories", and as such, I will place that request again to each of you here. If you group already has a history written up, could you send it in to us at the Archives, and if your group doesn't have one, would you consider creating one and sending it to both your local District, and to the Area for recordkeeping?

We spent most of our meeting discussing funding for our newly appointed Archivist to attend the 19th Annual National AA Archives Workshop. The resulting motion came forth to request ½ of the necessary funding to send our Archivist to the workshop. Discussion followed around the balance of the funding required. Numerous Districts have shown interest to participate in fund raising activities to generate the rest of the necessary funds. Since we are going to be asking for contributions, it was voted by committee to approach the Area 46 Treasurer and request her support to track and allocate the contributions. Upon agreement with the Finance Committee, and specifically, the Area 46 Treasurer, any specifically earmarked contributions will be made to the Area Treasurer, and allocated from the Area Treasury. This will keep 100% transparency for any specially earmarked contributions to send our Archivist to the National Workshop.

With the remaining time we discussed upcoming events. The Area Archives display will be setting up at the District 18 Service Workshop in May in Rio Rancho, and at the Area Convention in June in Hobbs, and again at NMCYPAA in August in Roswell. Several committee members volunteered to support our display at these events. Thank you volunteers. If you have any events coming up in your District, and would like have our Area Archives Display at your event, please feel free to contact me. Our Archivist continues to sort and digitize our Archives Holdings, and we are in the beginning stages of creating our database of the digital information. There will still be a lot of development to come.

## UPAA Committee

The Area 46 Young People's committee had 28 people in attendance at the March 7th assembly in Albuquerque. After introductions and a brief Committee report, we broke out into groups of five and discussed some questions many AA members have requested information on.

The first question dealt with unity and how we can foster inclusiveness within YPAA and in AA as a whole. Some suggestions were to hold workshops and include members who got sober young to share on how they have maintained sobriety through the years.

Second, we discussed some of the challenges that young alcoholics face that makes young people's meetings attractive; also discussing "What is unattractive about young people?". The feedback given was that the energy and enthusiasm for service are everywhere but that young peoples specific meetings may not attract all newcomers. We then introduced NMCYPAA and came up with ways to show support to Roswell this August. One suggestion was to utilize the existing service structure to outreach to your home groups and Districts. The last two questions discussed the direction of the Committee's next service project. We wanted to know what kinds of questions and information would be of use to districts and groups that may not know anything about YPAA.

The committee hopes to produce an YPAA informational PowerPoint for each district. Additionally, we want to utilize the YPAA committee web page to include a FAQ section, YPAA meetings by city in area 46, and to recommend literature that you may find helpful. We are creating more service positions at the District level. I would like to welcome the newest District 2 YPAA chair in Santa Fe! Thank you for this opportunity to serve. As always please let the committee knows if we can extend the hand of AA in your groups and districts.

## Grapevine Committee

There were 12 individuals in attendance at the *Grapevine* meeting held at the March 2015 Area Assembly. The committee discussed methods to develop interest regarding the *Grapevine* within groups and districts. Suggestions included the following 1) Some groups purchase a one year subscription for group members who celebrate one year of sobriety. 2) Some groups purchase a few subscriptions and place them in the 7th tradition basket and encourage members to take a copy. 3) Some groups utilize the *Grapevine* to pick a topic for meeting discussion. 4) Some *Grapevine* Representatives create poster boards that highlight *Grapevine* issues and other literature published by the *Grapevine*. These poster boards are set up with the literature display at Group and District meetings. There was discussion regarding the fact that many people may not be aware of all the other type of literature that is published by the *Grapevine* beyond the typical "Grapevine Our Meeting In Print."

There was some discussion regarding user challenges of the online version of the *Grapevine*. Members have been finding it difficult to search for particular topics in past issues that have been archived. One member of the committee is going to document the challenges they have been having and will circulate that document to other members of the committee. If there are no resolutions, the matter will be discussed at the September Assembly in Belen. The committee will decide at that point if the matters should be submitted to the Grapevine Publishing Committee for review and consideration.

#### Literature Committee

First, I want to thank Joseph, Henry and all of D-11 for putting on a great Area Assembly in Albuquerque on March 7-8.

The Literature Committee met at 9:40 AM with 18 members from 10 Districts present. Discussion started with the word "Moslem" in the forward to the 2nd Edition of the *Big Book* vs. the commonly used word today "Muslim." Suggestions included adding an asterisk and footnote to the page explaining: "In 1940's the word Moslem was a common use of people who 'follow Islam', but today the Arabic language describes the word 'Moslem as one who is evil and unjust', and that AA as a whole did not intent to be derogatory or belittle the followers of Islam."

Next we discussed several Literature agenda items that will be presented for comment or action at the General Service Conference in April which our Delegate, Jen N. will be attending. The first was the proposition to add the 12 Concepts to the back of the 12&12. Most thought it was a good idea, as long as they still printed the original 12&12. Questions arose over the cost increase, the need for more literature and also if it was just another way for GSO/AAWS to create more revenue. Most members thought that if the Concepts were in the 12&12, they would read and study them.

We then talked about the agenda proposition to publish a pamphlet specifically for the alcoholic with mental problems. It was first pointed out that most of us had mental problems when we first came to the rooms, but most of us recovered if we had the capacity to be honest. For those unfortunate ones however; such as traumatized, clinically depressed or those who suffer from other afflictions such as PTSD or OCD, it was generally thought to be a good idea to have an easy to pick up pamphlet which may shine some light to the still suffering alcoholic.

The other item was whether the recent price hike to the literature was necessary or not as the final audit for 2014 showed that GSO/AAWS were both financially sound. The question was whether GSO/AAWS was fear of future low book sales due to electronically downloaded AA literature, or was it just another example of todays acceptance of cooperate greed.

We asked Jen N. to look onto these questions in April and see if she can bring Area 46 some clear cut answers. We collected \$275.51 in book and pamphlet sales at the Assemble, which gives us a balance of \$515.61. (starting balance of \$240.10.) We collected \$16.24 from donations and "Books for Crooks" cans, which gave us the funds to buy a Retro Big Book to donate to the Assembly to the youngest AA member present.

#### Special Needs Ad Hoc Committee

We had twenty one people at the meeting. Area chair, Teresa F. spoke to the group and reiterated the purpose of the Special Needs Ad Hoc Committee which is: 1. Review the current needs of Area 46 with regards to special needs. 2. Review if a special needs committee needs to be established. 3. Determine if this is already covered under a current standing committee or if it should be a subcommittee of another current standing committee. 4. Make recommendations to the Area Chairperson as to their findings.

What we can do to serve at the group level is what we are trying to find out. A questionnaire asking about this was handed out to each DCM during the assembly. The importance of sticking to genuine needs was mentioned in our meeting as our scope of work will get too wide and we will lose effectiveness. Inventories that could be passed on to districts and made available to groups were found on the Internet. That could help determine current special needs. Phone calls to districts have indicated that some districts have a designated person to cover special needs. One district had two such people. Still another district had one who had moved away and they were looking for a replacement.

The idea of having a 'toolkit' for the area to distribute was suggested that could possibly contain information, inventories and helpful material. This was received positively by the group. Another suggested idea, a suggestion box along the lines of our 'ask it basket' for the group level was brought up. This could be a safe and anonymous way for someone to get help who might not be comfortable being more direct with the group. The need for people to be seated so that they can see the speaker's face has again been mentioned. Seating people in a horseshoe arrangement and/ or using a podium are ways to bypass this difficulty. It is hoped that the September assembly will consider this matter in their planning. If you are interest in participating on the Committee, please contact me or the Treatment Chair.




#### Finance Committee


