

MINUTES OF AREA 46 ASSEMBLY

AA New Mexico RECOVERY

March 7-8, 2015 District 11 – Albuquerque

SATURDAY

Assembly opened at 8:30. Meetings were held for standing committees, Trusted Servants, GSR's, DCM's and past Delegates.

Business Meeting opened with the Serenity Prayer at 1:55 pm by Area 46 Chair; Teresa F. Robert S read the preamble of the Area Assemble from the AIP; Melissa read our Traditions; Norma read a page from the Daily Reflections (English) and Carmin read a page from the Daily Reflections (Spanish). Housekeeping and announcements were made.

Introductions of All: Past Delegates, followed by Trusted Servants and Districts.

Secretary: Patty H., Area Secretary, read Summary minutes of December 2014 Assembly. Motion to accept minutes made by John T (D8); second: Myra T (D13). The minutes were approved unanimously.

Treasurer's Report: Teresa J, Area Treasurer –Remind you to check on the back table for 3 copies of a list of all the group contributions for that last 3 months which includes a total for 2014. Look up your group, write down your total contributions, take it back to your treasurer to ensure all of your contributions have been received. She went over the Area 46 Treasurers Report which shows a breakdown of how things are spent in the Area and is listed by category. Start with contributions: Read from the "green card" on the contributions. Went over the 2014 Summary. AIP is self-supporting. Total ordinary revenue for 2014 was \$26,180. Compared ordinary contributions (revenue) for 2013 vs 2014. 2013 had \$26,893 and 2014 had \$26,180. Self-contributions from just groups was \$21,870. Interestingly, in 2014 there were 155 groups who contributed (GSO shows apprx 355 groups registered). That's about 44% of the groups contributing. Compared to 2013, there were 144 groups who contributed (GSO showed 377 groups registered). There were only 113 "repeating" groups in 2014, so 31 who contributed in 2013 did not contribute in 2014. Where are those 31 groups that dropped? If you want to know who they are, there is a list. 44 new groups contributed in 2014. 2014 Expense overview (ordinary expenses): Assemblies 43%; Delegate Expenses 27.8%; Area-Wide services 13.3%; 12 Step work 4.2%; Operations 0.5%. We ended the year \$1021 available cash above reserves. January 1st when the budget changed, so did our prudent reserve. We still have to pay future assembly bills. If you have any questions, you can call me. Motion to approve Treasurer Report: Ed (D12); second Terry (D16). The 7th Tradition basket was passed during the report.

Registrars Report: Rosie F, Area Registrar: New Directory update going out. She compares your registration at the assemblies to what she has on file and always finds oddities. As of this morning there are 361 registered active groups in New Mexico and 456 inactive groups. There are groups listed as inactive but they are still meeting. If your group does not have a valid mailing address or someone who will receive your mail, then you are considered inactive. If you want to more about with this job entails, come and see me.

Delegates Report: Jen N, Delegate, Panel 64, Area 46 New Mexico: Last assembly there was some questions about the cost of the GSC so I have a presentation on the cost, the origin and the purpose. This evening is a sharing session – would like to get input from people on a few agenda items from the GSC. The plan is to come tonight and chose which topic you want to give your input on. The topics are: Finance and self-support: looking for feedback on what are useful ways to raise awareness on all levels; Grapevine raising awareness on Grapevine and LaVina; Two Literature questions – developing awareness for alcoholics with mental disorders and discussion on creating a new book, the 12 and 12 and 12; PI – comprehensive media plan is in brainstorming phase. Would like to go around and have Pre-Conference workshops. Had one in Alamagordo, one is coming up in Albuquerque on March 28. Current agenda items are posted on the website. Next weekend going to SWRDA in OK, April 18-25 I will be at the General Service Conference. This is the 3rd year of the conference inventory. We will be coming to the end of the process - there should be an inventory report coming out. Between now and September is the time to start making time for your delegate report when I come back from the conference. Also, next assembly is the voting assembly, if you have any interest in any of the Trusted Servants positions, please talk to

someone.

Alternate Delegates Report: Jim H. Panel 64, Area 46 New Mexico: Business has been really slow. The main thing is that I have been praying for the health of the Delegate (chuckle). I, too, will be attending the SWRDA in OK next weekend. Thank you for allowing me to go. So you can help me out, after the convention in Farmington, they donated their signs to the Area and they have gone missing. I take complete blame, because I gave them to someone.
