

# **MINUTES OF AREA 46 ASSEMBLY**

AAN Mexico Recovery

December 6-7, 2014 District 4 – Las Cruces

## SATURDAY

**Assembly opened at 8:30**. Meetings were held for standing committees, Trusted Servants, GSR's, DCM's and past Delegates.

**Business Meeting** opened with the Serenity Prayer at 1:45 pm by Area 46 Chair; Teresa F. Marsha S read the preamble of the Area Assemble from the AIP; Les H read our Traditions; Eloy M read page S51 from the Service Manual (English) and Leo read page S51 from the Service Manual (Spanish). Housekeeping and announcements were made.

**Introductions of All**: Past Delegates, followed by Trusted Servants and Districts.

**Secretary**: Patty H., Area Secretary, read Summary minutes of September 2014 Assembly. Motion to accept minutes made by John H (D4); second: Myra T (D13). The minutes were approved unanimously.

Treasurer's Report: Teresa J, Area Treasurer -She went over the 2014 Area 46 Treasurers Report which shows a breakdown of how things are spent in the Area and is listed by category. Wants the budget to be as simple as possible and not complicated. The bulk of our income is from our groups, which comes from a little over half of our registered groups. 151 groups contributed \$22,144 through the end of November. AIP is self-supporting, so your donations for that count as \$23,594 total revenue to date. We have \$19,817 total expenses to date. Net gain year to date is \$3,378. We still have December's income and expenses so we are exactly where we want to be. So far we have spent 46.3% on Assemblies, 4.8% on 12 Step Services, 15.3% on Area wide services and 33% on delegate expenses. We plan to have a small net gain going into the New Year. Traditionally, any overage returned from the Convention committee (after the prudent reserve is replenished), are sent to GSC to assist in the Delegate cost of the General Service Conference (above the \$1600 contribution that is already expected from us). She talked about the available cash above/below reserves (reserves are 50% of our annual budget). She discussed what our prudent reserves are and its uses. Currently we have \$25,629 in reserves and \$33,539 in the bank. The difference is \$7,910 above reserves right now is "available cash." From December 31st and January 1st, we go from the old budget to the new budget. The new budget is \$2,000 smaller than the old budget. Several guestions and concerns were addressed regarding contributions. The only money we give to GSO is the delegates' contribution to the conference (including the convention overage). Q - Do we know what the itemized costs are for our contribution to GSC for the \$7,000 for each delegate's expenses? A - This will be followed up on. Will be glad to sit with you if you need more explanation or to address any concerns you might have. Motion to approve Treasurer Report: Terry (D16); second Charly (D13). The 7th Tradition basket was passed during the report.

**Registrars Report**: Rosie F, Area Registrar: Made amends to some of the groups and Area. She did not get some of the groups' information into the GSO database. There were groups that should have been listed in the Directory and weren't. Again, I apologize (you live, you learn, and you rotate out). As of 2 days ago, there are 366 registered active groups in New Mexico and 451 inactive groups (if your group does not have a valid mailing address, you are considered inactive). It's important to let her know if you have any group changes. She compares your registration at the assemblies to what she has on file. If you want to know what your groups anniversary date is, give her a call.

**Delegates Report**: Jen N, Delegate, Panel 64, Area 46 New Mexico: We are at the end of our 1<sup>st</sup> year of the rotation. She talked about the conference and our three legacies: Recovery (Steps), Unity (Traditions) and Service (Concepts). Concepts can be found at the end of the Service Manual. She volunteered her services and said she would love to talk to you about the concepts for as long as you can stand it. Going around the Area, there were two issues that were commonly brought up: Anonymity (especially online and social media) and Singleness of Purpose. We have excellent literature on these, but literature is just a tool. What do they mean to us today and how do we put them into action? We also have issues with public controversy. We need to do our Public Information work and give out accurate information on what AA is and what AA isn't. Self-survey inventories are always good.

The 2015 International Convention is July 2-5, 2015 in Atlanta, there will be an area set aside for service entitled "Carrying the Message" and they are looking for volunteers. April's conference we will elect new SW Regional Trustees. Each of the 11<sup>th</sup> Areas in the SE Region will put forth one nominee. We will present our nominee later this afternoon for disapproval. Deadline for conference agenda items is December 15<sup>th</sup>. Let me know if you have any items. I would like to hold a few workshops (mock conferences) throughout the area (Northern, Central and Southern parts of the state) to talk more about the agenda items. I can make the conference material available to the DCM's. Tonight for the evening sharing session is our guest from GSO, Julio E., Staff Coordinator.

Alternate Delegates Report: Jim H. Panel 64, Area 46 New Mexico: Attended the SWRAASA in Corpus Cristi, TX with 3 other folks from Area 46 folks: Eloy M on corrections, Rosie F on registrar and Michael W from Central Office. I attended a great sponsorship workshop. Come see me later if you'd like to hear more about it. One highlight for me was meeting Dr. John Fromson, non-alcoholic trustee. On Saturday night the Alternate Delegates did a presentation on the concepts. Thanks to Teresa, Kurt and the finance committee and the work they do. Concerned with the 12 step workshops funds. Please be sure to use this for your service workshops. You can do a workshop on whatever topic you want and Area 46 will assist. Do not let that money go unspent.

**NMCYPAA**: Kelly (2015 NMCYPAA Chai), Bill (Treasurer) and Creighton of the committee. Conference (Secretary) will be in Roswell in 2015. August 14-16, 2015 at the NMU at the Roswell Campus. Theme will be "On The Wagon For Keeps". Held their first fundraise. It cost them \$106 and they made \$885. Planning a Valentine's Day fundraiser. More information to follow. **Motion 2: AIP Ad Hoc Committee:** "The AIP Ad Hoc Committee requests that the Assembly approve the slate of changes to the General Duties and Specific Duties in the AIP for Elected Officers and Standing Committee Chairpersons as presented for review. No funding required." Andrea T., AIP Ad Hoc Committee Member - Seconded: Bill L (D18) Motion **PASSED** unanimously.

**Motion 3: Special Needs Ad Hoc Committee:** "Up to \$525 to come from the contingency fund for travel to assembly expenses for 2015 for the Special Needs Ad Hoc Committee Chair." Lawrence M, Treatment Chair – Seconded: Jennifer B (D18). I opposed. Motion **PASSED**.

Motion 4: Web Committee: "To have Area 46 set aside \$2250 from cash on hand in excess of the prudent reserve at the end of year funds in addition to \$250 in the 2015 budget for the purpose of contracting with a programmer to finish development of the new Area 46 Website. Work will include enhancements to the databases use for Meeting Schedules, a face lift for the graphics and navigation, and revision to site navigation. Requirement criteria and acceptance testing requirements will be developed by the Website committee, which will be submitted for review and approval by the Area Chair, Alternate Chair, Treasurer and Finance Committee Chair. The same group will review bids prior to awarding of the contract." Brett B., Web Chair - Seconded: Ron N (D4) Motion **PASSED** unanimously.

Paragraph V.B.6. of the AIP (pg. 29) will be modified to reflect this change." Motion made by Kristoff, Finance Committee Member - Seconded by: Rosie F (D11). Motion **PASSED** unanimously.

**Motion 7:** Archives Committee: "Allocate \$125 to the Archives Committee to purchase computer equipment for Digitizing process, specifically; Office 2011 for Mac, and Amp iMac Cable for scanner." Estimated cost including tax, approximately \$125. Funding to come from the contingency fund. Motion made by Bill L., Archives Committee Chair - Seconded by: Zach D (D16). Motion **PASSED** unanimously.

**Motion 8: Finance Committee**: "In the section listing the Area Trusted Servants who are provided with money to cover travel and other expenses, paragraph V.B.3.g. (pg. 28) will be changed from "Archivist" to "Archives Chairperson." Motion made by Teresa J., Treasurer - Seconded by: Brent D (D13). Motion **PASSED** unanimously.
