2:30 pm SUMMARY OF MINUTES of December 2011 ASSEMBLY: Read by Ellen R., Area secretary. Motion to approve: Approved.

2:40 pm TREASURER'S REPORT: Francisco A, Area treasurer. At the end of February 2012, the balance was at \$19,400. In 2011 the Area budgeted \$31,000, spent about \$28,000 while taking in about \$26,000. Please see the Area Treasurer's report for more details. Due to the fact that Area 46 pays the \$5,200 cost of sending our delegate to the General Service Conference and the delay of contributions due to the new mailing address of the treasurer, the current balance seems low. This should balance out shortly. Carol, district 16, motioned to approve, Charlie B, District 15, seconded. Motion approved.

2:50 pm REGISTRAR'S REPORT: Bill L, Area Registrar; New AIPs available for \$1.50; reminded all new GSRs to register with him; asked for a volunteer to help with the computer work.

2:55 pm DELEGATE'S REPORT: Alan S, Area Delegate: Alan asked for a moment of silence to honor the passing of Orin, former delegate from District 4; shared how service work has benefited him through the home group, sponsorship (both personal and service), and how Concept 9 has proved very helpful in assuming leadership roles which in reality means to be of service; he gave an overview of his assignments at the 62<sup>nd</sup> General Service Conference on April 21-28,2012 in Rye, NY; anonymity at the electronic level will be discussed; e-books are available at aa.org; The Grapevine made a profit of \$23,000 for the first time this past year;; asked GSRs to remember GSO in their group contributions; he will try to attend the Conference with an open mind, not an agenda;; announced that the evening Sharing Session would be on "Anonymity Spiritual Responsibility in the Digital Age";

- Q: Would the following circumstances be considered to be breaking anonymity? I)AA members of a home group who disclose confidential/personal information about other group members (including their sponsees) to other members of the home group. 2) Is this easily dismissed as gossip? I am witnessing this happening in my home group and I believe it is harmful. Alan S answers: See the AA pamphlet "Understanding Anonymity " as a guideline, especially pages 8 & 10 in regards to this question. My responsibility is to protect your anonymity, not just my
- Q: Suggestions please on how to get old timers back into service, please. George, past delegate answers: If person not attending meetings or you don't see them, give them a call, invite them back. You can lead a horse to water, but you can't make them drink. Second question: Why is there a GSO and Intergroup? Isn't that duplicity? Which is the better of the two? George: Intergroups/Central offices operate at a local area. GSO is like and Intergroup for the USA and Canada (much more area covered) as well as doing translations and AA jobs that a local Intergroup can't afford; their work similar and complimentary. Q:How can someone from a small group with a small income afford to do service work? Why is AA Leaving those without a computer behind? Ralph T, past delegate answers: Remember that service work begins and is needed in your group. The primary purpose is to carry the message of recovery to the suffering alcoholic. If you're interested in participating in district and assembly functions, ask someone to share rides and rooming costs. SWRAASA delegates will be addressing the subject of AA for the Technically Challenged, but the printed materials aren't likely to disappear. Second question: Who knows where, when, how, why the debate regarding removing the word God out of the Big Book???????? Not the spirit of the higher power......Ralph: see this as a comment, not question; it'd take 3/4 of all AA groups to change anything in the Big Book, personal experience makes him glad that the concept in the book is as stated.
- Q. Do I have a voice? I am here at request of my DCM who I serve. An issue came up I wanted to speak about. Am I to speak on issues at the Assembly if I am not a voting member? Ray R, past delegate answers: The introductions done at the Assembly are meant to familiarize people with speaking into the microphone. Everyone has a voice at the Assembly. AA matters move slowly after much discussion so we all have the opportunity and  $\bar{a}$  responsibility to address a subject whether we are voting members or not.
- Q. Can a past DCM be a DCM again? Dave, District 10: Simple answer is yes. Circumstances and location will influence if this occurs. Is there a need for the service that I can provide? (Necessity and desire.)
- Q. Does it break Traditions to post fliers in rural neighborhoods announcing a new AA meeting in yards etc? Michelle, Area PI chair answers: Posting flyers and in yards is ok as long as you get permission and don't break someone else's anonymity.
- Q. Does anyone have information on sponsorship workshops? Theresa F, Area Alt chair answers: Check out the Area newsletter, El Farolita, or Box 459 from GSO; anyone can ask for a workshop to happen from their group, district or area (these are resources for you to use)
