2:30 pm **SUMMARY OF MINUTES** of September 2013 ASSEMBLY Dist. 5, Ruidoso; Read by Ellen R., Area secretary. Report approved; Motion: Lawrence M D14 Second: John T D8. 2:40 pm: **TREASURER'S REPORT**: Francisco A, Area Treasurer: Francisco reported on the activity as of Nov.30, 2013. The Area Chair and the Finance Committee chair review area finances monthly. The available cash over prudent reserve is \$14,401. He reviewed the percentages of the income sources and funding expenses. Report approved. Motion by Richard M D16: Second: Terry E D16. FINANCE COMMITTEE REPORT: Teresa J, chair: El Farolito evaluation showed it to be financially sound; could reduce prudent reserve to \$2,500; consider changing subscription rate; found that about half of all NM groups contribute to El Farolito. 3:00 pm REGISTRAR'S REPORT: Bill L, Area Registrar: Reminded DCMs of change registration packet given out at Sept. Assembly (which included a self addressed return envelope); he will/can get these changes to the GSO database and work with the in-coming registrar, Rosie F; appreciated the contact work of the DCMs. 3:10 pm **DELEGATE'S REPORT**: Alan S, Area Delegate: Alan thanked hosting D18 and welcomed all Assembly members; announced that all AAWS literature will be available on line through third party vendors with contracts protecting AA anonymity and in English, Spanish, and French; an anniversary 75th edition of the first printing of the Big Book is now able to be ordered; financially AAWS is operating at a planned deficit, but increased contributions and sales have reduced this amount; La Vina is improving but still operating at a loss (is financed by the General Conference Fund) while the Grapevine showed a profit again; (Alan's sidebar: If you don't like what you're reading in the Grapevine, write your own story, opinion. The Grapevine expresses all members' views.) The next General Service Conference will be considering bringing back the "Circle & Triangle" as the unofficial logo as well as possibility of medallion sales in order to stay financially sound. 5. Financial software motion:

Motion to purchase financial software (Quick Books) for the incoming Area treasurer.

Cost: \$205 from the contingency fund. Motion: Teresa J 2nd: Eloy M D3

6. El Farolito motion:

Motion to transfer up to \$1,500 of available operating cash on Jan. 1,2014 to El Farolito.

Motion: Teresa J 2^{nd} John D4 (Original motion had read:"to use up to\$1,500 of Available Operating Cash on Jan.1, 2014 to increase the Prudent Reserve of El Farolito. This was restated because it implied that the El Farolito prudent reserve was low, which it is not.)

7. Area Convention seed money motion:

Motion to increase by \$1,000 the amount of seed money provided by the Area to each District hosting the annual Area convention (bringing the total amount of convention seed money provided to \$5,000). The cost for this increase will come from Available Operating Cash on Jan. 1, 2014.

*10 opposed; minority opinion expressed; no majority opinion changed vote so there was no revote and the motion passed

8. Proposed 2014 Budget presented by Teresa J. No 2nd; Passed unanimously

No Committee breakout reports were given due to inclement weather so members could start for home. These will be published in the next edition of the El Farolito.

Jim H, Area chair, was unable to get a printed summary of the Saturday night Area Inventory but gave a brief verbal report and will e-mail copies to the registered members and will post it on the Area 46 website. Prayer, time and thought were put in with the incoming alternate chair before choosing. None were disapproved by Assembly."
