Motions:

- Motion to submit pamphlet developed by Ad Hoc Assembly Development Committee to GSO for possible inclusion as an Agenda item at the 2018 GSC For 79 against 6 no minority opinion motion passes
- 4. Motion to allocate\$387.30 from Contingency Fund for 4 worn out receivers. Motion passed unanimously

ASSEMBLY MEETING REPORTS:

Committee Chairs will submit their reports to be published in the October El Farolito.

Jeffrey H El Farolito editor did report that we need to ask our groups to step up contributions to insure continue publication. The El Farolito is self supporting and does not receive funding from the Area at the start of the rotation

Past Delegates: Ralph T reported only 3 PD in attendance. They mostly caught up with each other, called some of the past delegates and talked about the election to take place this afternoon.

Ask it Basket: What is the role of past delegates at Assemblies and Conventions? Some excerpts from page S46 of the A.A. Service Manual address this. It is suggested that Delegates do not succeed themselves as delegates or return to general service positions at the Area level but rather share their experience with world wide AA, accepting special assignments, conducting workshops when asked. They also attend SWARDA where past delegates from the Southwest Region share their experience with incoming delegates from the SW Region. It is hard to condense 3 paragraphs into a short report but it's there on page S46.

Sobriety Countdown: The signed Big Book went to Jarrod with 3 days and was presented by Diana T. with 40 years

At 9 a.m. Eloy M turned meeting over to Jim H Area 46 Delegate for the election process. The election was conducted by past delegates: Ray R, Ralph T, David L Jeff O and SW Regional Trustee Yoli F.
